- Customers unable to supply and ABN must trade COD (payment prior to dispatch)
- All orders are to be in writing.
- Our standard payment terms for Account Customers are 30 days from invoice date.
- An application for a 30 day account may take up to 7 working days to process; COD (payment prior to dispatch) accounts are normally set up within 48 hours.
- Customers waiting for approval of a 30 day account may order during this time and pay prior to dispatch.
- Payment of accounts can be made by Cash, Cheque, Money Order, Visa, MasterCard, EFT or direct deposit - please contact our Customer Service Team for the account details.
- Freight charges as per table above; please advise the Customer Service Team if you wish to arrange your own freight or pick-up.
- Credit Claims and/or Returns must be communicated and approved by our Customer Service Team within 10 days of receipt of the shipment.
