- All orders are to be in writing.
- Our payment terms for Account Customers are 30 days from invoice date. A 30 day account may take up to 7 working days to approve.
- Customers waiting for approval of a 30 day account may order during this time and pay prior to dispatch.
- Payment of accounts can be made by Cash, Cheque, Visa, MasterCard, EFT or direct deposit - please contact our Customer Service Team for the details.
- Credit Claims and/or Returns must be communicated and approved by our Customer Service Team within 10 days of receipt of the shipment.
- Orders can be submitted by fax, email or entered directly into our online website (www.valuebrands.com.au). Website orders are available for Australian Customers only.
- Ribtex International Pty Ltd is entitled to change their prices at any time.
- Without prejudice to any other right or remedy the customer shall indemnify Ribtex International Pty Ltd against any costs, fees, charges and disbursements charged by mercantile or collection agent or solicitor engaged for the purpose of the collection or recovery of monies due and payable by the customer to Ribtex International on an indemnity basis and all such costs shall be recoverable as a liquidated debt and, at the option of Ribtex International Pty Ltd, may be recovered in the Small Debts Court.
- The customer hereby acknowledges and agrees that Ribtex International Pty Ltd has a lien over all goods in its possession belonging to the customer to secure payment of any or all amounts outstanding from time to time.
- Retention of Title - While risk in goods shall pass on delivery, legal and equitable title shall remain with Ribtex International Pty Ltd until we have received the payment in full therefore pending such payment the customer shall hold the goods as bailee for Ribtex International Pty Ltd and shall return the goods if so requested. Notwithstanding the foregoing the Customer as judiciary may sell or deal with the goods in the ordinary course of business whereupon the bailment shall immediately terminate.
- In respect of goods already delivered, Ribtex International may enter the customer's premises to recover and re-sell same for its own benefits.
